Karelus, Berkowitz and Wagner also won the 400-yard freestyle relay over Blue Devils Kautzman, Pollack, Mike Smith and Burstein who finished second at 3:27.77.

Berkowitz added, "When I found out that he got disqualified for wearing the cap, I was very surprised. I felt sorry for him." Berkowitz related the strategy on the 500-yard freestyle.

Rowe captured first in the 200-yard freestyle at 1:49.18, touching just ahead of Pollack who finished at 1:49.39. Kolterjahn took third at 1:57.23, Blue Devil Devin Power placed fourth at 1:58.65 and Steve Swenson finished sixth at 2:04.37.
